Annual Physical and Bloodwork Reminder

Remember to complete your annual physical including bloodwork and submit it to Wellworks For You before May 31, 2024 to earn the Wellness Credit of \$720 (employee and spouse/significant other must complete) or \$360 (single) per year. This must be completed **EACH YEAR** to qualify for the Wellness Credit!

Eligibility

1. You must be enrolled in one of Bancroft's Medical Insurance Plans.
2. Complete your Annual Physical and Lab Work
3. Submit the Annual Physical and Lab Work to Wellworks **no later than May 31, 2024**.

NEW! Enhanced Wellness Credit

Bancroft is excited to announce an improved Wellness Credit Program for FY2025. **For instructions to earn the wellness credit, see the following page.**

When you consent to add Sena Health to your support team before May 31, 2024, you can **increase your Wellness Credit** to \$960 (employee and spouse/significant other must complete) or \$480 (single) per year beginning July, 2024.

EARNING THE WELLNESS CREDIT



As a reminder, we **now have a lab voucher for Labcorp**. You **do not** need a lab slip from your physician if you use the voucher. Simply follow the instructions on the voucher to schedule at a Labcorp location and remember to print and take the voucher with you to your lab appointment. You should schedule your annual physical for after your lab work has been completed to give your doctor a chance to discuss those results and ensure you are receiving the right medical care. **Submit your physical and labwork to Wellworks For You by May 31st, 2024.**

To earn the Wellness Credit, you must complete the physical/lab work (and submit the form to Wellworks) every year. Visit www.wellworksforyou.com to download your Annual Physical Screening 2023-2024.

Completion Instructions

Complete an annual physical with lab work in one of two ways:

Option 1:

Complete bloodwork with your primary care provider (PCP) during, or prior to, annual preventive physical. Print out the **Option 1: Physician Results Form Packet** located within the Wellness Locker linked on the homepage and take the form to your PCP to be completed and signed. Submit completed Physician Results Form via Wellness Portal **by May 31**.

Option 2:

Complete bloodwork at LabCorp using the lab voucher and review results with PCP at annual physical. Follow the LabCorp Voucher instructions found in the **Option 2: Lab Voucher Packet** located within the Wellness Locker linked on the homepage to schedule your LabCorp appointment. Once scheduled, print out the voucher within your packet and bring it with you to your LabCorp appointment. LabCorp will send the results directly to Wellworks For You for processing. After completing your bloodwork, print the **Proof of Visit Form** from the same packet and have the form signed by your PCP at your annual preventive physical. The Annual Physical Screening requirement is met when bloodwork is complete using the lab voucher and the signed Proof of Visit form is received by Wellworks.

Submission Deadline

All metrics must be collected between June 1, 2023, and May 31, 2024, and submitted to Wellworks For You via the Contact Us or Upload a Form feature by May 31, 2024, to receive credit. Please allow ample time when scheduling your annual physical, as well as time for blood work to be processed by the lab and received by your PCP's office before your appointment.

Please Note:

It is the participant's responsibility to ensure the completed form is submitted by the deadline. It is advised that you retain a copy of your completed form to ensure submission to Wellworks For You.
